

n September 11, 2001, while we looked on with horror at the images of the terrorist attack on the Twin Towers in New York, the sorrow we felt for you overwhelmed our families, as it did 25 years ago.

Your tragedy revived our most devastating memories. The anguish and the wait for a phone call, the clinging hope for a report of possible survivors; the terrible blow of the confirmed dead; the desperate search for a trace to identify our loved ones among the remains; the void created by their absence; the incurable feeling of



knowing everything we were supposed to do together in the future ...

October 6, 1976 was our September 11.

On that date, a Cubana Airlines jetliner exploded in mid-flight close to the coast of Barbados. It was the first terrorist act against a civilian plane in this hemisphere, and cost the lives of 73 passengers and crew members.

That day, many of us awaited our sons and daughters, some teenagers, who were coming home from winning the youth championship in fencing in Caracas, Venezuela. Those who bid them farewell at the Caracas airport have told us that they boarded the plane with their medals on their necks and with a joy that was contagious to the rest of the passengers. One of them, Nancy, 23 years old, champion fencer with an individual gold medal, was pregnant. The rest of us awaited our fathers, wives and husbands, brothers and sisters...

All of them died without knowing who condemned them to death and why. During all these years, their families could not help but try to imagine what they experienced after the two explosions, in the midst of the fire. From the depths of the sea only a few unrecognizable remains were recovered. Nothing more.



"... After Bosch's arrival in Caracas in September he stated during a fundraising dinner that 'Now that our organization has come out of the Letelier job looking good, we are going to try something else.'

A few days later, Posada allegedly said, 'We are going to hit a Cuban airliner'and 'Orlando [Bosch] has the details."
